3. Every article/research papers should be labeled as: A research paper or case comments or book review etc.
4. Tables, if any, should be numbered consecutively. Title of the table should appear above the table and sources at the bottom.
5. The Author is required to take note of (i) originality of the theme (ii) novelty of the subject (iv) clarity of the idea (iv) presentation of subject systematically and (v) linkage of conclusion with the contents.
6. Foot notes and citations of research work are to be given as per the format of Indian Law Institute available at www.ili.ac.in .
7. Only works which have not been published earlier or which are not being considered for publications elsewhere will be entertained.
8. Manuscript not accepted for publication will not be sent back to contributors.
9. All the manuscripts of research articles/research papers shall be submitted to the Editor via (Email: head_law@pbi.ac.in).
10. Send both hard and soft copy in duplicate to the Head, Department of Law, Punjabi University, Patiala 147002, Punjab.
